The following Limited Warranty backs all repairs performed at Drury Body Shop, Inc.

Drury Body Shop, Inc. hereby provides a Limited Warranty on repairs performed by the shop. This Limited Warranty is valid only for as long as you own the vehicle stated herein, and is for the person to whom this Limited Warranty is granted and whose name appears herein and on the original work order. This is a labor only; fragmented five – part Limited Warranty, and stipulations pertaining to each fragmented part are stated hereafter:

1. **METALWORK:** Drury Body Shop, Inc. provides a LIFETIME LIMITED WARRANTY on all metalwork, to include welding and the application of materials utilized in making collision repairs against cracking, flaking, pitting or deterioration, excluding rust repairs, any metalwork warranted hereby, at its sole option, when claim is made while the present owner stated herein owns the vehicle, unless caused by or damaged resulting from unreasonable use, maintenance, or care of the vehicle.
2. **PAINTING, STRIPES AND DECALS:** Drury Body Shop, Inc. provides a LIFETIME LIMITED WARRANTY on painting-related priming and painting work against solvent blistering, peeling, hazing, and excessive loss of pigmentation. The Shop will re-prime, re-paint, re-stripe or re-decal the specific section or sections of the vehicle warranted hereby (excluding rust repair or damage resulting from unreasonable use, maintenance or care of the vehicle.)
3. **MECHANICAL REPAIRS:** Drury Body Shop, Inc. provides a TWELVE (12) MONTH LIMITED WARRANTY on all mechanical repairs pertaining directly to original collision damage, excluding suspension, air conditioning or other electrical assemblies or components. The shop will re-repair any mechanical assembly or component warranted hereby, at its sole option, when claim is made within twelve (12) months of the effective date stated herein, unless caused by or damaged resulting from unreasonable use, maintenance, or care of the vehicle.
4. **PARTS:** Drury Body Shop, Inc. PROVIDES A LIFETIME LIMITED WARRANTY, unless mfg. Warranty is less, on NEW OEM parts installed by or at the Shop, excluding suspension, air condition or other electrical assemblies or components. (Please Note: Shop warranty does not exceed Mfg. Warranty.) The Shop will repair or replace any defective part warranted hereby, at its sole option, when claim is made while the present owner stated herein owns the vehicle, unless caused by or damaged resulting from unreasonable use, maintenance, or care of the vehicle.
5. **PAINTLESS DENT REPAIR:** Drury Body Shop, Inc. PROVIDES A NATIONAL LIFETIME WARRANTY, on all workmanship associated with PAINTLESS DENT REPAIR to the vehicle owner who receives the services on the vehicle stated herein.
